* This tap fee schedule is for wastewater customers on a decentralized wastewater service system, such as Stonebridge / Old Parksville Ridge / Hidden Ridges. Tap fees assume typical, residential usage. If tap is made for account with 1" or larger meter, or unusually large consumption, the wastewater service will be sized accordingly and priced at cost plus 25%.

Tap fee rates are defined for typical installations requiring no more than 50 linear feet of collection service line. Installations further from right of way will be charged installation cost plus 50%. This will be collected prior to installation.

** The standard system tap rates apply if service is connected outside a development designated as connected to a specific decentralized wastewater treatment facility.

*** This usage rate schedule applies to customers connected to a decentralized wastewater service system such as Stonebridge / Old Parksville Ridge. This flat rate will segue to the District's standard usage rate as of 01/01/2024.

**** Standard Equivalent Dwelling Unit is one typical home unit based on 150 gallons usage per day average. Larger customers will be assessed a SEDU value based on number of units if multi family, or based on usage/anticipated usage for commercial or light industrial applications.

***** Services measuring more than 100' from the pump/tank installation to the sewer main will be charged a service charge that represents the cost of additional maintenance expense that the longer service will require.
